## STANDARD TERMS AND CONDITIONS OF SALE - CONTROL COMPONENTS NORTH PTY LTD (CCN)

1. Our Terms and Conditions (T&Cs) form an integral part of all proposals and quotes.
2. Prices are based on factory prices, exchange rates, freight, duty and primage rates available at the time our quote was prepared. Changes of 5% or greater in any of these factors may amend the prices.
3. Prices are valid for 30 days from the date of quotation.
4. Prices do not include Goods and Services Tax (GST).
5. Final decision on the suitability (fit for purpose) of all products, including but not limited to material selections, remains with the purchaser and is assumed to have been made and accepted as such with any written approval for CCPL to proceed with supply.
6. Delivery is Ex-Works (EXW) - Miranda NSW 2228 unless indicated otherwise. Orders received without specifying a preferred carrier account to be used, will be shipped on our account and attract our standard freight charge + GST.
7. Purchases for 'non-stock, custom made or configured products' are acknowledged by email. Purchasing / manufacturing will **not** proceed until **written** approval is received by email to [phil.bolger@ccezy.com.au](mailto:phil.bolger@ccezy.com.au)
8. Custom Order and Made to Order products are non-returnable.

### **Payment terms:**

9. Purchases for "non-stock, custom made or configured" products by Non-Account customers, will require a minimum 50% deposit with order before it will be put into production.
10. Purchases from non-account customers and first orders from newly established account customers, must be **paid in full** before shipment.
11. Our payment terms are 30 days net from date of invoice, unless approved in writing by prior arrangement.
12. Title to the goods will not pass until payment is made in full.

### **Warranty:**

If within twelve (12) months from date of delivery, any defect is discovered in any item manufactured by our principles in respect of material or workmanship, and reasonably within their control, we undertake to make good the defect at our own expense, provided that the notice is given to us as soon as discovered and that the item is, if required by us, immediately forwarded to our address accompanied with Return Authorisation (RA) supplied by us but carriage paid and with seals unbroken.

Our responsibility is in all cases limited to the cost of making good the defect in or replacing the item itself, as deemed most suitable by us and detailed in the RA.

**Continued use of an approved trading account with Control Components, is deemed to indicate acceptance of our trading terms.**
