Installation . . .

Unless otherwise specified at time of purchase, units are calibrated in a vertical position, with lead wires up. Install unit in piping system, using standard pipe fitting procedures. Hold inlet fitting with wrench at installation to prevent fitting torque accumulation. Be sure to keep thread sealing compound out of unit. Make sure that flow is in proper direction - marked "IN" and "OUT" on housing. See wiring diagrams for electrical connections. CAUTION: See "Switch Ratings" before connecting power.






Electrical Connection (1/2" NPT Conduit)




Maintenance . . .

Accumulation of foreign debris should periodically be removed from these switches. Occasional "wipedown" cleaning when excessive contamination is present is all that is normally required. To clean: Remove unit from system and disassemble as shown below. Clean all parts, reassemble and reinstall unit.
